VHHA Hosts 2025 Virginia Healthcare Workforce Summit as a Virtual Event

- This week, VHHA hosted the **2025 Virginia Healthcare Workforce Summit** as a virtual event with programming and speakers focused on exploring innovative strategies for hospitals to adapt their practices related to developing, recruiting, retaining, and supporting team members in a rapidly changing workplace. Summit sessions delved into engaging and retaining a multi-generational workforce, building flexibility to meet evolving needs, fostering internal mobility and career development, and adopting cutting-edge models to address workforce challenges. Additional topics included advancing virtual nursing, leveraging artificial intelligence for workforce planning, and refocusing leadership approaches to empower teams. VHHA Holds Meeting of the Board of Directors' Executive Committee

- The **Executive Committee** of the **VHHA Board of Directors** met this week for a discussion of issues of interest and importance to hospitals and health systems, including state legislative and federal policy issues.

VHHA Wins Top Award from Mid-Atlantic Society for Healthcare Strategy and Market Development

- This week, VHHA was honored at the [Mid-Atlantic Society for Healthcare Strategy and Market Development](#) (MASHSMD) Annual Conference in Dewey Beach, DE with the 2025 Best Overall (Platinum) Award for Integrated Marketing Campaigns. VHHA received that award for the [Control Your Care](#) public awareness campaign, which was [launched](#) to help educate the public about personal health care rights under a series of consumer-friendly policy reforms approved in recent years by Virginia lawmakers with support from hospitals. Research conducted by VHHA showed that the vast majority of Virginians weren't aware these consumer-friendly reforms exist. VHHA invested in developing a website as well as paid and earned media campaigns to inform people about their health care rights under the law, including consumer-friendly policy reforms from recent years on surprise medical bills, medical debt collection, price transparency, and good faith estimates. At the MASHSMD conference, VHHA also received a Bronze Award in the Content Creation and Management category for the Help Us, Help You initiative – a video public awareness campaign featuring [powerful, personal stories from frontline nurses who have experienced workplace violence](#). This work was inspired by feedback from hospital members who continue to experience rising incidents of health care workplace violence. Those members asked VHHA to lead efforts on raising awareness about this growing problem and [appropriate behavior expectations in hospital settings](#).

- In April, VHHA and the **VHHA Foundation** hosted the **2025 Virginia Healthcare Emergency Preparedness Summit** at The Westin-Richmond. “Today’s Challenges, Tomorrow’s Impact” was the theme for the in-person event, during which participants engaged with speakers, sponsors, and support organizations from across the Virginia health care community regarding opportunities to strengthen the Commonwealth’s preparedness for threats to the health care delivery system including severe weather, active aggressor incidents, crisis standards of care considerations, and special pathogens response. Register for VHHA-IHI Open School Quality and Patient Safety Certificate Program

- Now is the time to register for the latest cohort of the [IHI Open School](#) Certificate Program in Quality and Patient Safety offered by the **VHHA Center for Healthcare Excellence**. Since the first offering in 2021, hundreds of participants have completed the 13 required courses and have been recognized at the annual **Virginia Patient Safety Summit**. Now in its fourth year, Virginia health care professionals looking to gain quality and patient safety improvement knowledge are invited to register to join the IHI Open School courses to earn a certificate in quality and safety. Content is delivered through narrative, video, and interactive discussion. There are 13 core courses to earn the Basic Quality and Safety Certificate (17.75 CE credits available for the 13 courses) and [more than 30 courses](#) available in total for Continuing Education and Specialty Board Certification. The courses offer a dynamic learning environment for health care professionals of all levels and are available as self-paced online modules that are estimated to take 13-22 hours to complete. Those who register will be contacted by e-mail before June 1, 2025, with instructions about how to log in. Participants will have access to all courses from June 1, 2025-May 30, 2026. Those who complete the certificate by Jan. 31, 2026 will be recognized during the 2026 Virginia Patient Safety Summit. The VHHA group rate cost to enroll is \$199 (\$399 without the group rate). News Updates

Legislative Proposal on Medicaid Cuts Clears U.S. House Energy and Commerce Committee

This week, the **U.S. House Energy and Commerce Committee** voted to approve [draft legislation](#) regarding proposed Medicaid policy and funding changes as part of a broader budget reconciliation package with the intent of reducing programmatic spending by hundreds of billions of dollars over the next decade. The Committee legislation is among a package of bills working their way through the

process as part of a larger budget package of proposed tax cuts and spending plans pending further action and potential approval by Congress. Preliminary estimates by the **Congressional Budget Office** (CBO) indicate the proposed Committee legislation would reduce the federal deficit by \$912 billion over a decade, including \$715 billion in savings from reductions in Medicaid. CBO also projects the legislation could result in at least 13.7 million more individuals without health insurance by 2034. The legislation would establish more frequent eligibility redeterminations to prevent duplicate enrollment. It would also require certain able-bodied adults ages 19 to 64 without dependents to work at least 80 hours per month or participate in community engagement activities to maintain Medicaid coverage. The proposed legislation seeks to limit the growth of Directed Payment Programs (DPP) while incorporating grandfather clause language that specifies any programs that received written prior approval before the date of enactment would be capped at the levels outlined in its currently approved preprint and State Plan Amendment (SPA). Preserving funding mechanisms such as the State Directed Payment Program is essential for sustaining high-quality and affordable care for Medicaid beneficiaries across the Commonwealth. The draft legislation maintains the current Federal Medical Assistance Percentage (FMAP) model rather than shifting to per capita caps or block grants. Meanwhile, the **Centers for Medicare & Medicaid Services** (CMS) recently issued a [proposed regulation](#) intended to address a loophole regarding Medicaid provider assessments used to generate program revenues. The proposal seeks to add safeguards “to ensure that tax waivers” for certain health care-related levies meet statutory requirements. A 60-day public comment period is being offered on this proposal. White House Issues Executive Order on Pharmaceutical ‘Most-Favored-Nation’ Pricing for U.S.

This week, **U.S. President Donald Trump** issued an [executive order](#) declaring that “Americans should not be forced to subsidize low-cost prescription drugs and biologics in other developed countries, and face overcharges for the same products in the United States.” The order directs the U.S. Secretary of Commerce to engage with pharmaceutical makers “to bring prices for American patients in line with comparably developed nations” through regulatory action “to impose most-favored-nation pricing.” It also directed the U.S. Secretary of Health and Human Services to “facilitate direct-to-consumer purchasing programs for pharmaceutical manufacturers that sell their products to American patients at the most-favored-nation price.”

This week is **National Hospital Week 2025** (May 11-17). Virginia joins the nation in celebrating National Hospital Week, which is a time to honor the dedication, compassion, and care provided by hospitals and their teams to support and strengthen communities. Hospitals are pillars in our society that offer essential medical care to people in need, drive clinical research leading to advances in care and patient outcomes, help form the first responder safety net in emergencies, and support the economy. The **Virginia Hospital & Healthcare Association** (VHHA) counts among its members 26 health systems that represent 113 community, children’s, psychiatric, rehabilitation, and specialty hospitals. Each of those organizations is home to physicians, nurses, technicians, caregivers, and other professionals with a passion for improving health and an unwavering commitment to delivering high-quality care to patients. In recognition of Hospital Week 2025, [Virginia Governor Glenn Youngkin has issued a formal proclamation honoring the work and contributions of Virginia hospitals](#). VHHA is also celebrating the week with an [online contest awarding gift cards](#) to select Virginia hospital employees who are nominated by others. VDH Seeks Survey Responses to Improve Neonatal Abstinence Syndrome Awareness

The **Virginia Department of Health** (VDH) is seeking survey responses to improve public health reporting and surveillance of Neonatal Abstinence Syndrome (NAS), which is a condition that affects newborns exposed to opioids or addictive substances in the womb, causing them to experience withdrawal symptoms during their first few days of life. By participating in this brief survey, clinicians will help identify key areas where additional support or resources are needed. This survey will provide valuable insights into the challenges and barriers faced when reporting NAS cases, helping VDH develop better educational tools to support health care providers across the state. All responses will be used for VDH's evaluation efforts and any data shared will be reported in aggregate to ensure privacy. Health Sector Coordinating Council Shares Health Care Cybersecurity Report

The **Health Sector Coordinating Council** (HSCC) recently shared a new [report](#) titled "On the Edge: Cybersecurity Health of America's Resource-Constrained Health Providers." The report highlights how resource-constrained health care systems including small, rural, and critical access hospitals, family clinics, skilled nursing facilities, and federally qualified health centers (FQHC), among others are only marginally prepared for ongoing cyber threats to clinical care and operational liquidity. It also recommends forms of support needed amid stiffer cybersecurity regulatory requirements.


VHHA *Patients Come First* Podcast Features Sheltering Arms Therapist, Micro-Farm Rehab Program
